

# St. Luke's Hospital Education to Employment Laboratory Science Scholarship Program

The scholarship program at St. Luke's Hospital (SLH) in Chesterfield, MO and St. Luke's Des Peres (SLDP) in Des Peres, MO is designed to provide financial support for Laboratory Science Students enrolled in an accredited laboratory science program. Our goal is to raise awareness, increase the number of laboratory scientists entering the profession and provide opportunities for employment at our St. Luke's Hospitals. Two \$5,000 scholarships will be awarded.

### **Admission Criteria:**

- Enrolled and accepted into a full-time NAACLS accredited MLS or MLT program and graduate within 12 months.
- Résumé.
- Have a minimum GPA of 3.0 or higher on a 4.0 scale.
- A transcript verifying GPA and current enrollment.
- Letter of recommendation from the program director.
- A typed 300-word essay on why they have chosen laboratory science as their profession.

# **Required Commitments:**

- Complete clinical rotations in the lab as assigned.
- Must work as Medical Technician Student on a per diem basis, variable work schedule (minimum of two shifts per month).
- Required to work 2 years post-graduation as a full-time Certified Medical Technician / Technologist (36 hours a week).













# **Laboratory Science Scholarship Program**

## **Application Process (applicant is responsible for the following):**

- Scholarship application.
- Members of the SLH and SLDP Laboratory leadership team will serve on the review and selection committee.

#### Timeline:

- Open application period: July 30 August 12, 2022
- Review and selection process: August 15, 2022
- Recipients notified by: August 19, 2022
- Disbursement issued: within 10 days of meeting all the criteria. Taxes apply.

### Awarded scholarship will be repaid within 10 days by the applicant in the event:

- A recipient fails to successfully complete the academic year.
- A recipient receives a grade under 2.0 (C or below), recipient is required to submit grades each semester.
- A recipient does not obtain the MLT/MT II certification will be downgraded to a level I within a year.
- A recipient does not complete 2 years of employment as a MLT or MT after finishing the academic program
